Vehicle Importation, Sales, and Maintenance Services Complementing our distribution capabilities, Gulf Treasures engages in the importation, sale, and servicing of heavy-duty trucks essential for petroleum transport. ocated within the Ibru Complex, Apapa, Lagos. This facility boasts a significant combined storage capacity exceeding 53 million liters. Meticulously engineered and maintained, the terminal is designed to meet the dynamic demands of our diverse clientele, ensuring the secure storage and uninterrupted flow of various petroleum products. Advanced monitoring and safety systems are integrated throughout the terminal to guarantee operational integrity and compliance with international standards.

Logistics and Transport Fleet: Our logistical capabilities are powered by a modern and diverse fleet. This includes a significant number of high-capacity tankers (40,000 litres) and smaller distribution trucks (11,000 litres peddlers) for versatile delivery solutions. We also operate specialized vehicles, including containers and trailers, supported by a fleet of well-maintained trucks. This extensive fleet ensures efficient and reliable transportation of products to client sites, retail outlets, and our own mega stations across Nigeria.

Retail Network (Mega Stations): Our retail presence is marked by a network of 31 strategically located mega filling stations. These stations are designed to provide convenient access to quality petroleum products and exceptional customer service to the public.




